

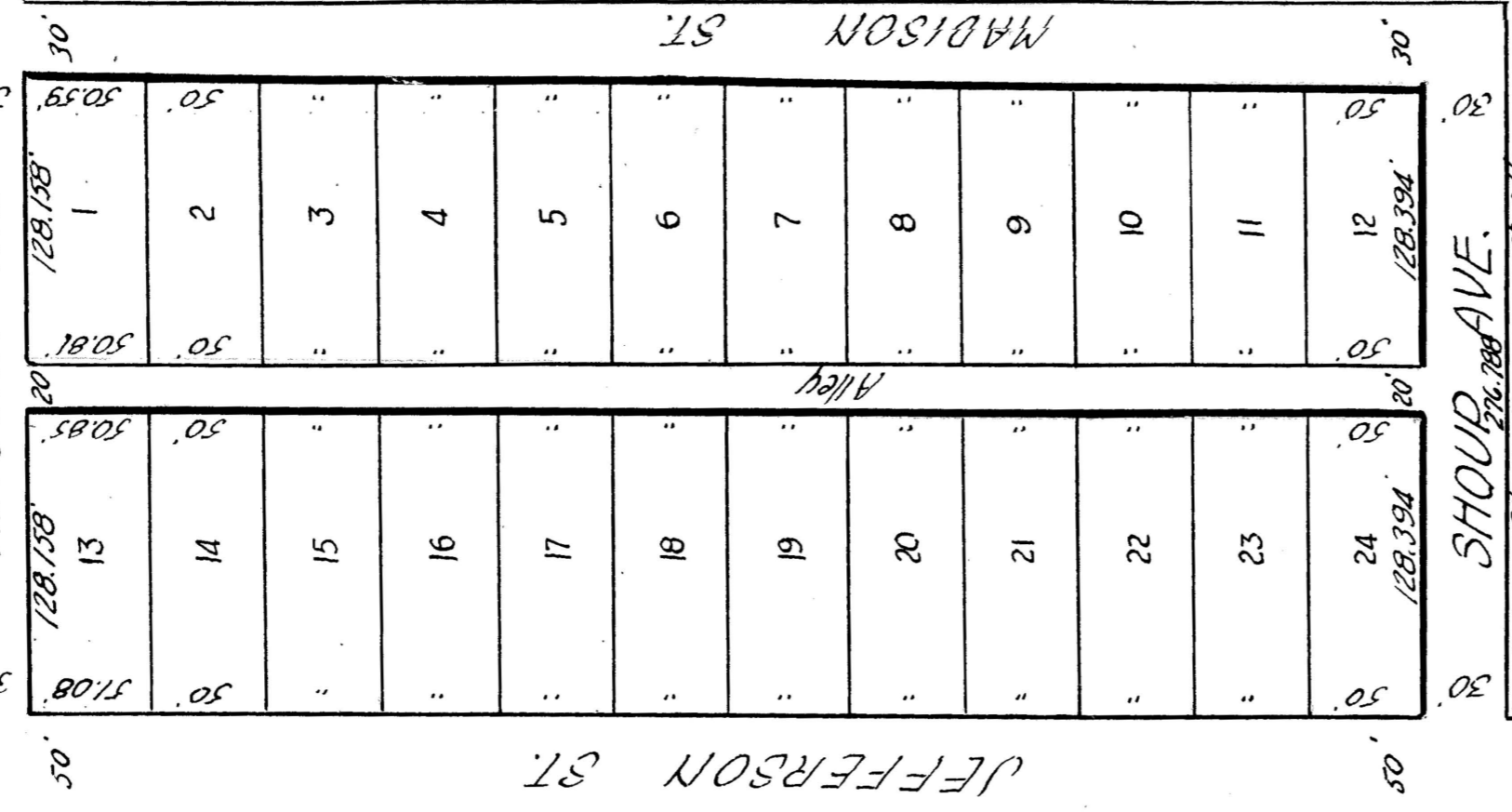

KNOW ALL MEN BY THESE PRESENTS: That we CHARLES E. DAVIDSON and LILLIAN M. DAVIDSON, being the owners of the lands herein described do hereby certify that the following is a true and correct description of the lands included in the DAVIDSON'S SUBDIVISION, which are represented on the above plat: said lands being known as the WEST HALF of Blks. 11 and 12 of Moorman's 1st Addition Twin Falls, Idaho - the same being situated in the SW 1/4 SW 4 Sec. 9, Township Ten South, (T. 10 S.), Range Seventeen East of Boise Meridian, (R. 17 E. B. M.) Twin Falls County, Idaho, and said parties do further certify that it is their intention to dedicate the same in said plat, and that, in consideration of the filing of said plat by the County Recorder, and the acceptance by the public of the streets and alleys shown thereon, do hereby give and grant to the public forever in fee simple - such portions of said premises as are on said plat set aside for that purpose.
