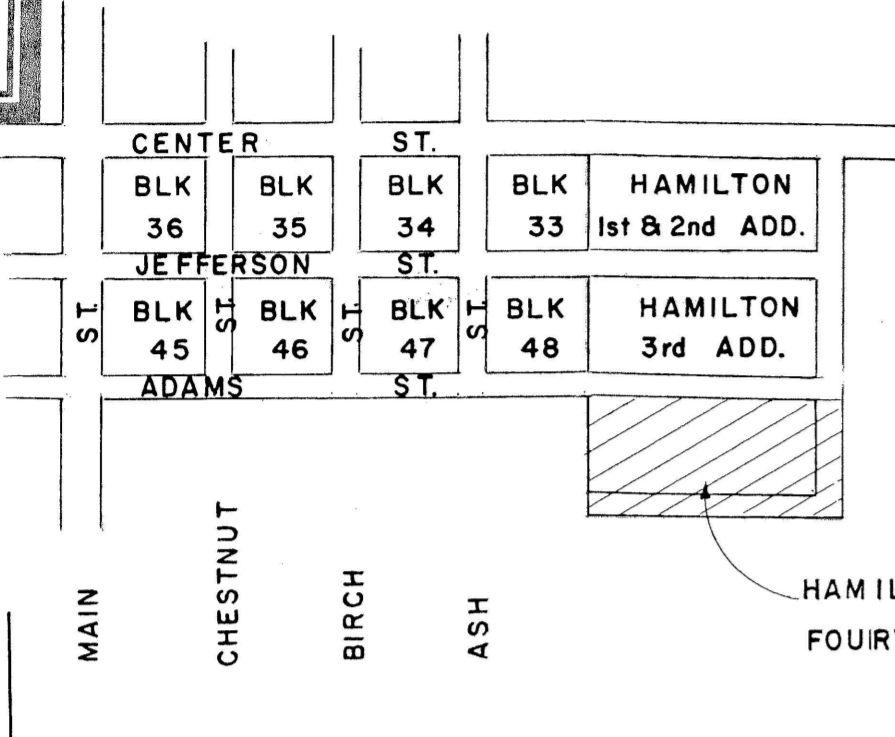


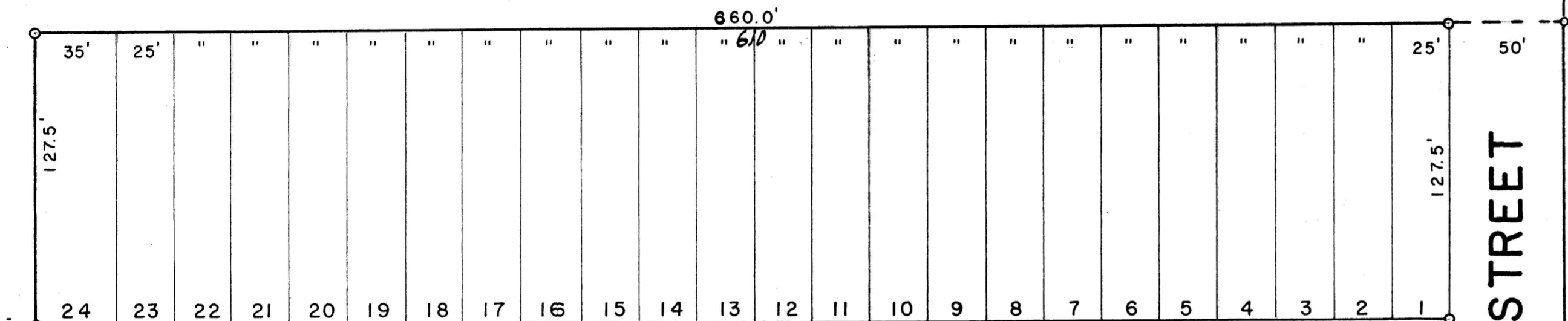

LOCATION MAP

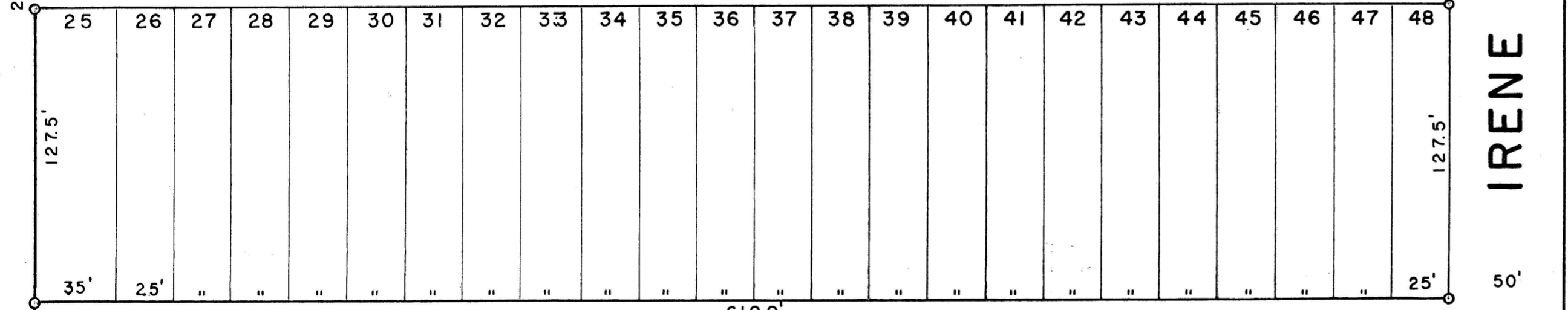


HAMILTON THIRD ADDITION

ALLEY

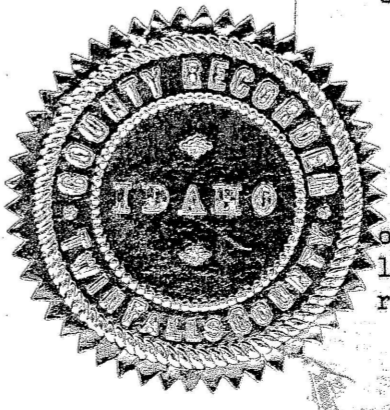


WASHINGTON STREET
