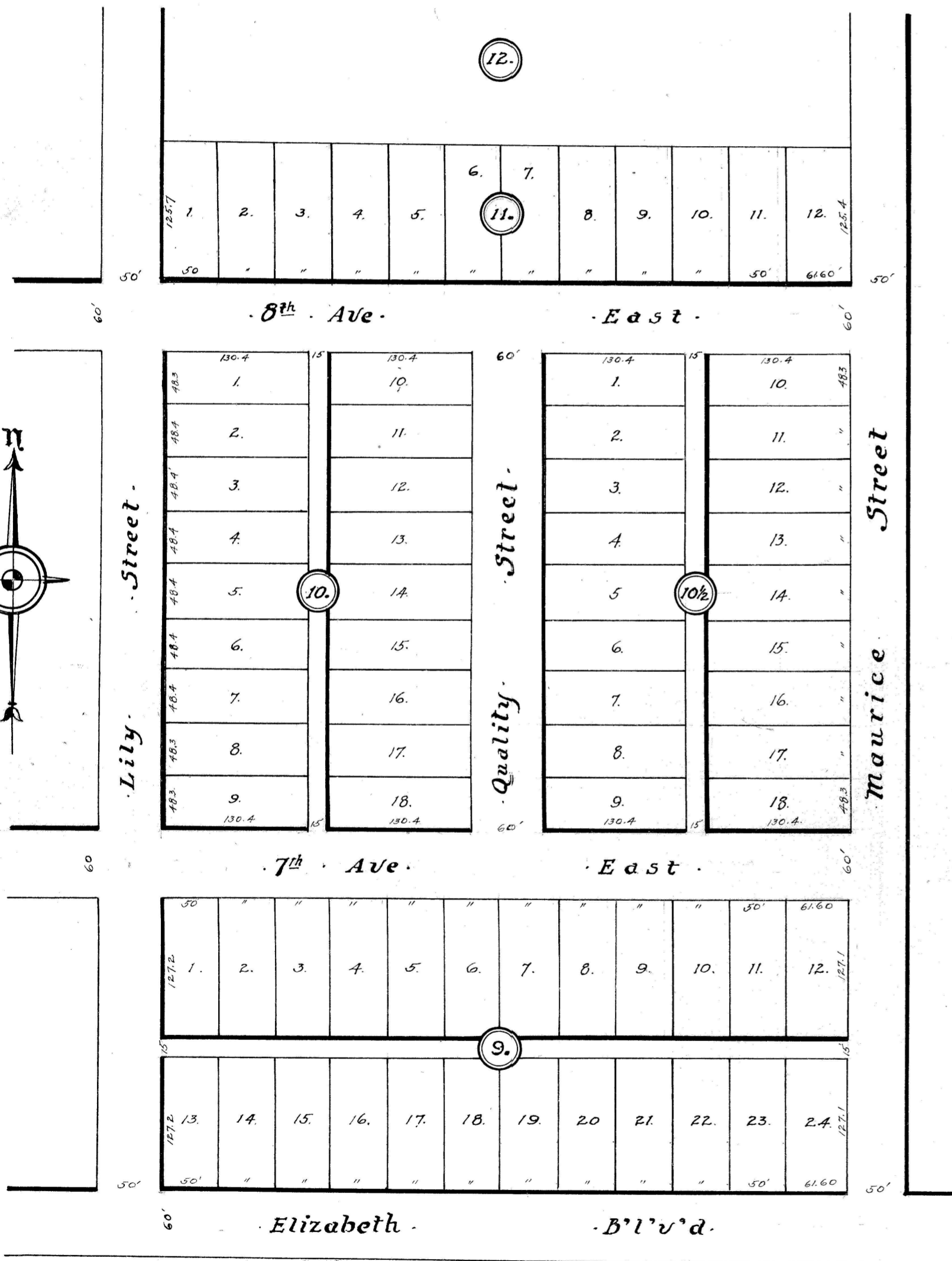

KNOW ALL MEN BY THESE PRESENTS, That I, the undersigned do hereby certify, that the following is a true and correct description of the land included in MURTAUGH'S SECOND ADDITION, which is included herewith, said land being known and described as the Revised Plat of Block 9-10-11, MURTAUGH'S SECOND ADDITION TO TWIN FALLS, IDAHO. And I do further certify that it is my intention to include the same in said plat thereof, and that in consideration of the filing of said plat by the County Recorder of Twin Falls County, Idaho, and the acceptance by the Public of said streets shown on said plat, do hereby give and grant to the Public forever in fee simple, such portion of said premises platted as are on the said plat set aside for streets for Public use forever.
