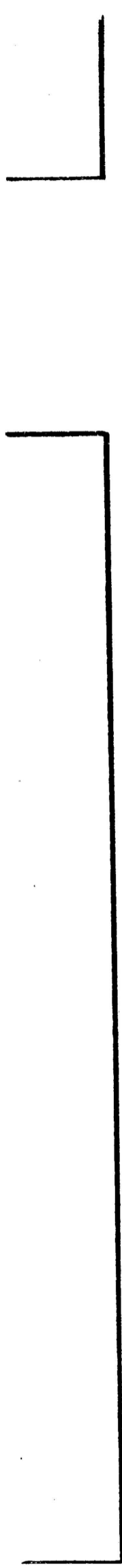
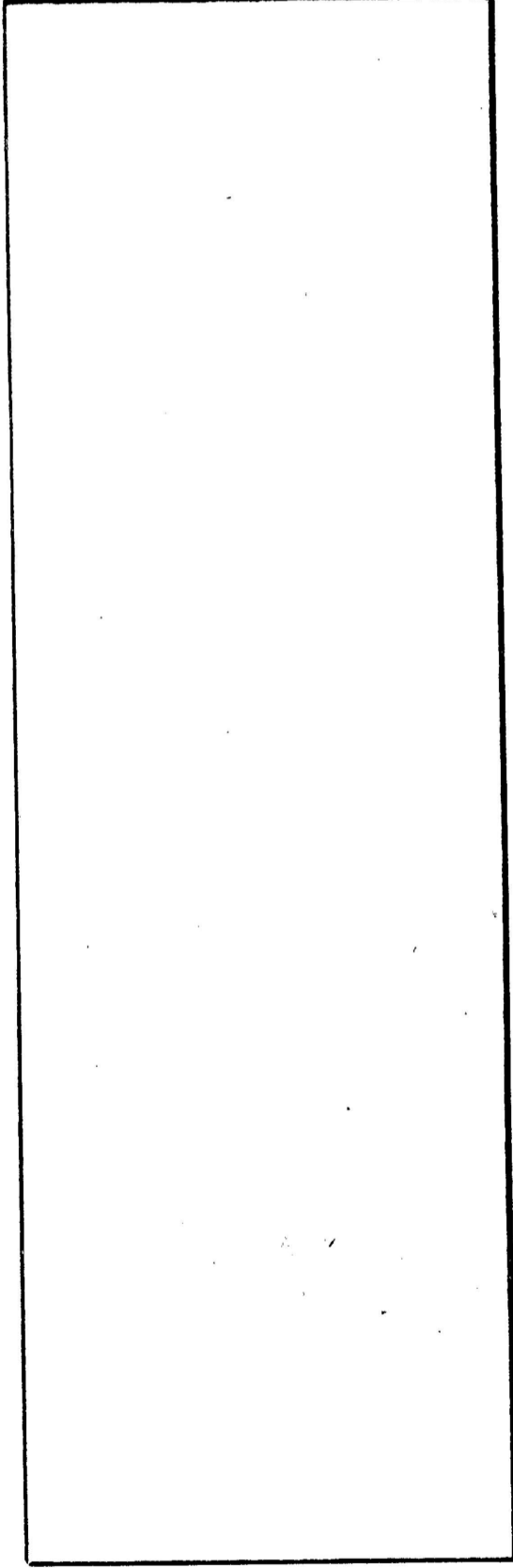


PARK SUB-DIVISION OF BLOCK 102.

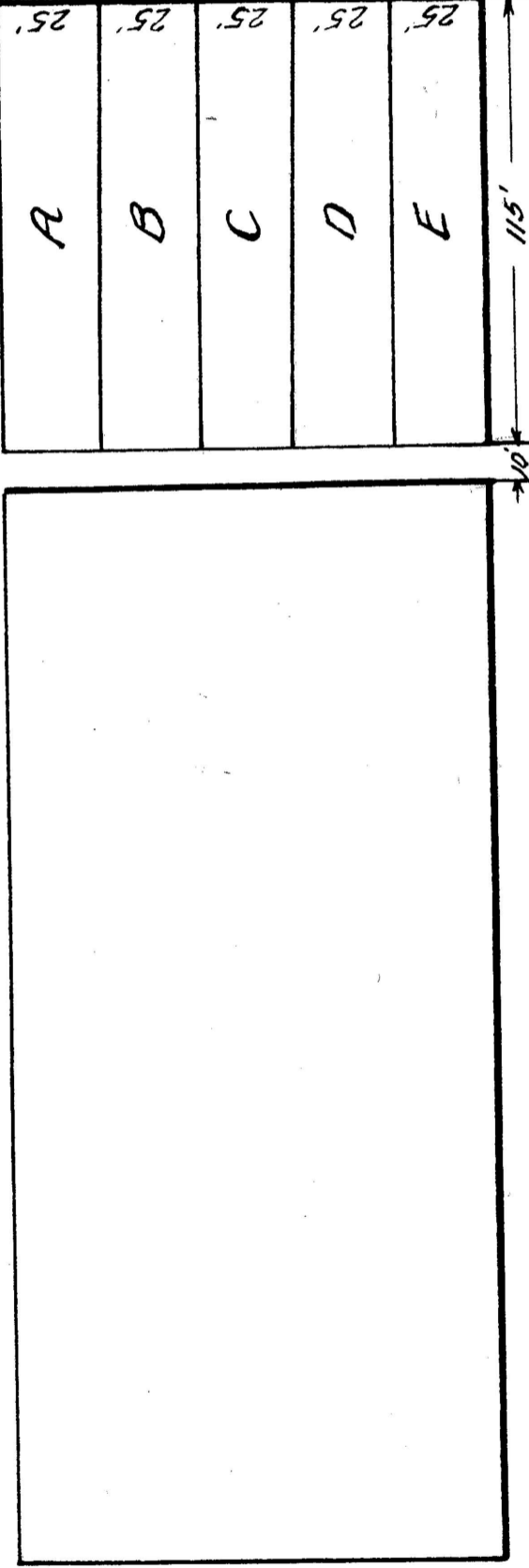
